










# **SAV Group Structure**






# Company's Service Process Overview

- Airline operators must obtain flight permission from SSCA concurrently with submitting credit applications to the CATS before commencing flight operations.
- SSCA is a government agency of Cambodia that controls and oversees the operations of CATS.

  Responsibilities include:
  - Approving aircraft flight plans
  - Determining the coordinates and rates for air navigation service charges
  - Approving flight plans by CATS
  - Ensuring compliance with standards set by the International Civil Aviation Organization ("ICAO")
  - o Conducting annual reviews of air traffic controller licenses
  - Monitoring the operations of CATS

SSCA is entitled to receive revenue-sharing from CATS under a concession.
















# **Service Income Composition**

(THB Million,%)




# 2023 Flight movement with diversified customer base

# International Landing & Take-off 23,238 flights, 25%


















# Flight Movement 2002 - 2027













### **Total Revenue**




### **Net Profit Margin**


